Moved Bren Fitzgerald seconded Jack Treasure that the minutes of the previous meeting be accepted.

REPORTS: Jack Treasure reported on the symposium held at the Clunies Ross Hall by the M.D.C.A.V.

General discussion about the symposium - it was announced on the North East Radio Station. It was felt that the publicity was not enough after the symposium the Sun and the Stock and Land both had small articles. Preceeding the event the Weekender had an article in it twice and there was an add in the Age. Lial McCready reported on his meeting with Mr. Dimmick and said that the L.C.C. have made their report on the submissiosns, but it is being held up for political reasons. He suggests that we have a meeting with the parliamentarians (local members) and that we should get to know Dr. Molls successor (Forest Commission) Prices Justification Tribunal did not know store Cattle Industry existed and they are looking into it.

Jack Treasure suggested that we circulate letters to local council and parliamentarians on our policies.

David Gunter outlined wilderness area which takes part of his, Hodges and Gilders runs and suggests another area.

And the Graeme Stoney Jack Purcell and Frank Ryan also write letters opposing the boundaries on the L.C.C. recommendations map forwarding these to Jim Commins who will then write a supporting letter to the Chairman of the L.C.C.
