PADDOCKS TO PORCELAIN - AN EXHIBITION BY DON PORTER & LORRAINE HANSEN.

I recommend this Exhibition of paintings by our Don Porter and porcelain painting by Lorrain Hansen to everybody. The Exhibition is being organised by our very own Ros Andrews and will run from the 13th to the 19th July at the Cato Gallery, Victorian Artists Society, 430 Albert Street East Melbourne. The official opening will be at 7:00 p.m. on Thursday 13th July. Please try to get to see this Exhibition, it will be well worth a visit.

TRAVELLING STOCK LEGISLATION DISCUSSION PAPER.

In February, at the request of the Minister for Roads and Ports the Hon. Bill Baxter, Mary Goldsworthy and Allan Brewer presented to VicRoads Advisory Board a discussion paper setting out the MCAV concerns regarding travelling stock on roads. This was the first time that an outside group had addressed the Board, and was most successful.

MCAV has long been concerned at the lack of uniformity in regulations regarding travelling livestock on roads, lack of uniformity in signage, difficulty and confusion regarding any defence to litigation which may be brought following an accident involving travelling livestock on roads, and a lack of driver education.

At the present time all rural Shires throughout the State have their own particular local laws and regulations regarding droving stock. The confusion occurs when stock have to be driven through several different Shires with often very different regulations. In some cases droving is almost impossible, and it is easier, although costly, to move stock by road transport.

The experience in New South Wales is quite different. There the regulations are uniform, as is signage, and the Road Users Handbook sets out the obligations of drivers when encountering livestock on roads.

MCAV set out the problems and solutions in its discussion paper, and joined with the V.F.F in a working group to come up with resolutions and advise the Minister.

It has been acknowledged that there is no easy solution to the problems of stock on roads, but the work is being done, and a resolution cannot be very far away.

EASTERN FOREST REGION

MCAV has put a proposal to the Department of Conservation and Natural Resources regarding the creation of an Eastern Forest Region including bush grazing licence areas and undeveloped Crown land in order to separate this area from the 'rest of the State' in matters of management and for the setting of fees. The first

proposal was not accepted by the Department for various reasons, but we have requested further discussion with the Department to see whether the proposal has merit in principal, and how best we can work with them to achieve this goal.

ENVIRONMENT EFFECTS STATEMENT - MT STIRLING

The Consultants appointed by the Government to prepare an Environment Effects Statement have released a range of 6 Options for the mountain and have asked for public comment. The Options range from continuing the existing use of the mountain with enhanced management measures, through various low impact priorities, to cross country skiing, cross country/down hill skiing, through to a major ski resort and village. At the present time the majority of the community views support the first Option, however there is a great deal more water to flow under the bridge before a final decision is reached.

MCAV has observer status on the Consultative Committee which is assisting in the preparation of the E.E.S.
