Our announcement that newsletters were only going to be every 6 months was slightly premature!

All our supporters should be informed regarding several important matters, so we decided to circulate everybody.

ROYAL MELBOURNE SHOW - 18th to 28th SEPTEMBER, '86.

The Mountain Cattlemen have been asked to demonstrate their craft by driving a small mob of cattle down Swanston Street as part of the Royal Show Street Parade. The Mountain Cattlemen are to be featured amongst some 80 entries. After some consideration, the Executive have left the final decision on the drive to the Mansfield branch, and the Lovick family. It was considered that the Lovicks would have the most reliable cows and calves for such an exercise. The Mansfield branch will have a "practice run" shortly in Mansfield, and a final decision made after problems, if any, become obvious. It is hoped that each branch will finance and send at least 3 or 4 good horsemen to help with the Royal Show drive on Sunday, September 14th. It has been put most strongly to the Royal Agricultural Society that the exercise will be non-political, and that we welcome the chance to do something more in our line - other than political demonstrations. If the exercise does go on (and it jolly well should, the R.A.S. are counting on it/- S.S.) we expect a great deal of media coverage similar to Tim Austin and his 1,500 merinos in last year's Parade. We believe that it is important to keep the Mountain Cattlemen before the public in a non-political way, and this offers us a golden opportunity to be seen in Melbourne again.

The Cattlemen and Associates were offered, and we have accepted, a shop of our own at the Show. The shop is in a very good position on a main thoroughfare near the horses and the main arena, and we expect to sell heaps of windcheaters, t shirts, stickers, posters etc. Ross Brown has ordered stocks, and we are very excited about the whole project.

The Show shopis going to need lots and lots of assistants. We will have to open from 10a.m. until 7 p.m. each day. The planning of a roster is an enormous and daunting task, however Keith and Anne Whittam have taken on the challenge - bless their hearts! - and agreed to co-ordinate the staffing and administrative side of the project with Sue Silvers' assistance. We will need at least eight people on duty each day of the Show (passes have already been arranged). FLORA & FAUNA CONSERVATION GUARANTEE

Serious concern is mounting throughout the farming community about this proposed Legislation. Executive Officer Graeme Stoney has written a very strong submission on behalf of the Mountain Cattlemen, condemning the proposals. The Cattlemen say that the Legislation could give mischievous individuals or extreme Conservation groups a tool so powerful that the use of renewable resources found on Public land could be almost halted. It is hard to see why such Legislation is needed when present Legislation covers the protection of native flora and fauna adequately. Both Opposition parties have been approached on the subject of the Legislation with the object of having either the Bill stopped, or water-tight safeguards written into it. A bitter fight appears to be looming.

NATIONAL PARKS BILL

As we expected, the Minister has signalled her intention to fight on, and reintroduce the Bill in the Spring session of Parliament. We are not sure that she can do this unless the Bill is substantially altered, or Parliament is prorogued. The Liberals and the Nationals have been contacted and both appear firm in their resolve, unless the Bill is dramatically different, and allows for sensible multi-use of the area. PLEASE CONTACT YOUR LOCAL MEMBER OF PARLIAMENT ABOUT THE FLORA & FAUNA CONSERVATION GUARANTEE AND THE NATIONAL PARKS LEGISLATION. Please voice your concern to your local Member. The Mountain Cattlemen believe cur organisation must show a lead, and highlight to politicians and the media the damage both pieces of Legislation will inflict on the State's economy, and on the community's ability to utilise renewable resources on both private and public land.

President Jim Commins has covered grazing fees and other issues. There is an excellent 3 page article in the latest "Bushdriver" 4 x 4 magazine about the Cattlemens issue. Ken Connley has gained some publicity through Aukubra Hats. Graeme Stoney has discussed the Flora & Fauna Conservation Guarantee in the newspapers, and the Cattlemens message has been quite clear. Bill Scott, an Assocate member from Gippsland has spoken to a group about the Cattlemen, and is a valuable spokesman down that way with further engagements coming up. Sue Clay and family of Moorooduc, new Associate members, have never actually met any of the Cattlemen, yet have embarked on a remarkable mission. They have collected over 3,000 signatures for a Mornington Peninsular Petition which they will get their local Member to present to the Parliament in the Spring. Sue believes in what the Mountain Cattlemen stand for and she has gone out and done something about it. The Cattlemens Nunawading involvement and the subsequent police investigation got a run in Tom Duggan's column in the Age in early July. He was emphasising the obvious cover-up of the affair and creating an expectation that there is more to come.
